Raised \$12,601.49 dollars in collaboration with the Akron Aids Collaborative and the Akron NAACP for the family of Jayland Walker, who was murdered by the Akron Police Department.



Supported Dr. Pamela Wind's successful campaign for the SMF Board of Education (BoE) through direct donations, social media campaigns, a published interview and candidate profile, and by completing door-to-door canvassing.

Helped pass the recent SMF Schools Levy by canvassing, completing literature drops, and via social media and text campaigns.

Disseminated resources for the November 2022 Election, including a sample ballot and information on issues and candidates.


